It all began in June 1994, when Simpson became the prime suspect in the brutal slaying of his former wife, Nicole Brown Simpson, and a friend, Ronald L. Goldman. After trying to flee from the police in a wild car chase that was broadcast live across the nation, Simpson was charged and arrested. The subsequent murder trial, dubbed "the trial of the century," became one of the longest-running, most widely covered and most racially divisive court cases in U.S. history.
