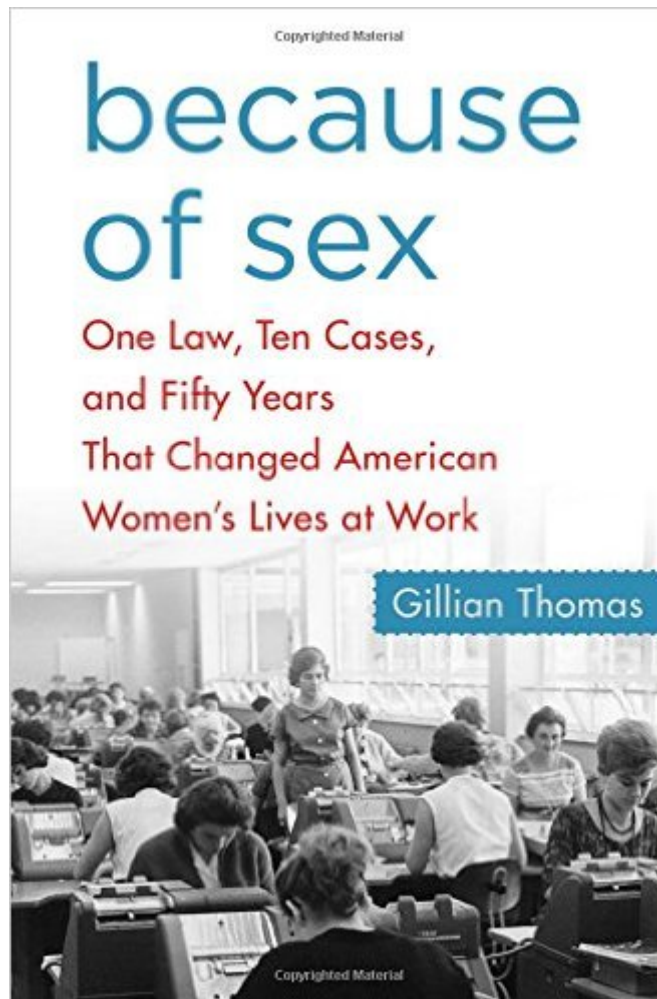

Because Of Sex: One Law, Ten Cases, And Fifty Years That Changed American Women's Lives At Work

Really enjoyed this story of how the court slowly awarded women equal rights -- and even thought I

had watched this happen real-time as I was growing older, it still came as a shock to see how recently some of these gains were made. I don't think most young women these days do not realize how different things were when their mothers and grandmothers were young.

This overview of the cases related to gender based discrimination was entertaining and informative. With each chapter focusing on one case - the flow is easy to stick with - and avoiding the repetition common in other books of this type.

Thomas explores the nuances in these cases without losing the reader, carefully explaining legal terms and strategy without a hint of condescension and without disrupting the narrative. I initially picked up a copy from the local library, but ordered my own copy after reading the first case because I know I'll want to revisit this one.

One of my favorites genres is nonfiction that reads like fiction, and this book is a great example. Vivid, jargon-free narrative brings the cases to life and makes you mad all over again about the discrimination and indignities and bullsh*t working woman faced -- and sadly are still facing. Buy it for yourself (at your local independent bookstore, of course) and be sure to get extra copies for the women in your life - mom, aunt, sister, daughter, grandma, babysitter, letter carrier, CPA, barrista, etc. They will thank you!

As much as I enjoyed the book, I can't help but wonder if this election cycle will put women's rights back a half century or maybe to the stone age. This book, while deeply researched and rigorous, is the opposite of legalese. Thomas's vivid, thoughtful, witty storytelling reveals the real (and courageous) people behind the cases that made employment discrimination law what it is today. It shows not just the impact of law on people, but the impact of people on law. These women's struggles (and those of the advocates at their side) are both infuriating and inspiring. (That was me on the subway yelling at the book, alternating between "WHAT THE HELL?!" and "YOU GO, IDA!") Read it on the train, read it on the beach; just read it. I have a zillion friends with spring birthdays, not to mention my mom (who came of working age during this gender-siloed Mad-Men-tastic era) and I'm buying it for every single one.

I loved this book! Gillian Thomas does a fabulous job of explaining how sex discrimination law has developed over the past fifty years. Based on in-depth interviews with the women who brought these cases and their lawyers, as well as meticulous research, the book offers a unique behind-the-scenes look at ten famous Supreme Court cases. These women are truly unsung heroes -- and everyone who has benefited from their courage (which is to say, all working women) owe them a debt of gratitude.

Because of Sex is a fantastic book. The editor Charlie Peters used to say that journalists are good at covering laws when they're being passed but not about the impact of those laws once they're in effect. Because of Sex delivers the goods. It uses a series of court cases to tell us what the 1964 Civil Rights Act has meant for women's equality. It's not only original, well-researched history but also a compelling read.
